3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW Irritating to eyes, respiratory system and skin. The toxicological properties of this material have not been fully investigated. Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.
