Emergency Overview

Skin Contact: Causes irritation to skin. Symptoms include redness, itching, and pain. May be absorbed through damaged or burned skin with symptoms similar to inhalation and ingestion.

Eye Contact: Causes irritation, redness, and pain.

Chronic Exposure: Repeated exposure may cause symptoms similar to those listed for acute effects.

Aggravation of Pre-existing Conditions: Persons with pre-existing skin, eye, blood or central nervous system disorders, or impaired liver, kidney, or pulmonary function may be more susceptible to the effects of this substance.

4. First Aid Measures

8. Exposure Controls/Personal Protection
