3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

Toxic by inhalation, in contact with skin and if swallowed. Moisture sensitive.

Potential Health Effects

Eye:May cause eye irritation.

Skin:May cause skin irritation. The toxicological properties of this material have not been fully investigated.

Ingestion: Harmful if swallowed. May cause irritation of the digestive tract.

Inhalation:May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated.

Chronic:Repeated or prolonged exposure may cause CNS stimulation.

4 - FIRST AID MEASURES

5 - FIRE FIGHTING MEASURES
