3. Hazards Identification

Emergency Overview As part of good industrial and personal hygiene and safety procedure, avoid all unnecessary exposure to the chemical substance and ensure prompt removal from skin, eyes and clothing.

Inhalation: Mild alkaline irritant to respiratory system. Coughing, sneezing, possible breathing difficulty in acute cases.

Eye Contact: Mild irritant, possible reddening due to alkaline effect or abrasion.

4. First Aid Measures
