3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

The toxicological properties of this material have not been fully investigated. Moisture sensitive.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation.

4 - FIRST AID MEASURES

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

5 - FIRE FIGHTING MEASURES
