3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

Hygroscopic (absorbs moisture from the air).The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye:Dust may cause mechanical irritation.

Skin:May cause skin irritation.

Ingestion:May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

Inhalation:Inhalation of dust may cause respiratory tract irritation.

Chronic:Repeated inhalation may cause chronic bronchitis.

4 - FIRST AID MEASURES

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

5 - FIRE FIGHTING MEASURES
