#### 3. Hazards Identification

**Emergency Overview CAUTION! MAY CAUSE IRRITATION TO SKIN, EYES, AND RESPIRATORY TRACT. MAY BE HARMFUL IF SWALLOWED OR INHALED.**

**Inhalation:** May cause irritation to the respiratory tract. Such effects, however, have occurred. Symptoms may include vomiting, lethargy, diarrhea, blood chemistry effects, heart disturbances and central nervous system effects. The toxicity of phosphates is because of their ability to sequester calcium. **Skin Contact:** Irritant due to its acidic nature. May cause inflammation and pain on prolonged contact, especially with moist skin. **Eye Contact:** May cause irritation, redness and pain. **Chronic Exposure:** May sequester calcium and cause calcium phosphate deposits in the kidneys.

#### 4. First Aid Measures

**Inhalation:** Remove to fresh air. Get medical attention for any breathing difficulty.

**Ingestion:** Give large amounts of water to drink. Never give anything by mouth to an unconscious person. Get medical attention. **Skin Contact:** Immediately flush skin with plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. Wash clothing before reuse. #### 8. Exposure Controls/Personal Protection
