#### 3. Hazards Identification

**Emergency Overview** As part of good industrial and personal hygiene and safety procedure, avoid all unnecessary exposure to the chemical substance and ensure prompt removal from skin, eyes and clothing.

**Inhalation:** Not expected to be a health hazard.

**Ingestion:** Mildly toxic by ingestion. Systemic toxicity is unlikely unless massive amounts have been swallowed. Drinking water with > 500 mg/L may result in gastrointestinal irritation.

**Skin Contact:** No adverse effects expected.

**Eye Contact:** No adverse effects expected but dust may cause mechanical irritation.

#### 4. First Aid Measures

**Inhalation:** Not expected to require first aid measures. **Ingestion:** Give several glasses of water to drink to dilute. If large amounts were swallowed, get medical advice. **Skin Contact:** Wash exposed area with soap and water. #### 6. Accidental Release Measures

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Spills: Sweep up and containerize for reclamation or disposal. Vacuuming or wet sweeping may be used to avoid dust dispersal.

#### 7. Handling and Storage

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from incompatible substances. Containers of this material may be hazardous when empty since they retain product residues (dust, solids); observe all warnings and precautions listed for the product.

#### 8. Exposure Controls/Personal Protection

**Appearance:** White efflorescent crystals or granules.

**Odor:** Odorless.

**Solubility:** Soluble in 1.5 parts of water @ 25C (77F).

**Specific Gravity:** 1.46

**pH:** Aqueous solution is neutral.

**10. Stability and Reactivity.**

**Stability:** Stable under ordinary conditions of use and storage. Effloresces in dry air.

**Hazardous Decomposition Products:** Oxides of sulfur and sodium may form when heated to decomposition. **Hazardous Polymerization:** Will not occur.

**Incompatibilities:** In combination with sodium sulfate, aluminum and magnesium will explode @ 800C (1472F); strong mineral acids and bases.

**Conditions to Avoid:** Air, incompatibles.

**11. Toxicological Information**

Investigated as a tumorigen, mutagen, reproductive effector. No LD50/LC50 information found relating to normal routes of occupational exposure.
