#### 3 - HAZARDS IDENTIFICATION

##### EMERGENCY OVERVIEW

Irritating to eyes, respiratory system and skin.Hygroscopic (absorbs moisture from the air).

Potential Health Effects

Eye:Causes eye irritation.Skin:Causes skin irritation.

Ingestion:Low hazard for usual industrial handling.Inhalation:Causes respiratory tract irritation.

Chronic:Chronic absorption of formic acid may cause damage to the kidneys, which is indicated by albuminuria and hematuria. Chronic skin contact may cause sensitization dermatitis, particularly in workers previously sensitized to formaldehyde.

#### 4 - FIRST AID MEASURES
