#### **3 - HAZARDS IDENTIFICATION**

EMERGENCY OVERVIEW Harmful if swallowed. Irritating to eyes, respiratory system and skin.Hygroscopic (absorbs moisture from the air). Potential Health Effects Eye:Causes eye irritation. May cause chemical conjunctivitis. Skin:Causes skin irritation. Ingestion:May cause gastrointestinal irritation with nausea, vomiting and diarrhea. Inhalation:Causes respiratory tract irritation. Can produce delayed pulmonary edema. Chronic:Effects may be delayed.

4 - FIRST AID MEASURES

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately. Skin:Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Ingestion:Never give anything by mouth to an unconscious person. Get medical aid immediately. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation:Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

#### **5 - FIRE FIGHTING MEASURES**
