#### 3. Hazards Identification

Emergency Overview WARNING! HARMFUL IF SWALLOWED OR INHALED. CAUSES IRRITATION TO SKIN, EYES AND RESPIRATORY TRACT. Inhalation: Causes irritation to the respiratory tract.
